

Foster to Adopt Agreement

As a participant in the Foster to Adopt Program with 716 PAWS, with the intention of adopting the fostered animal, I agree to comply with the following conditions and requirements. By signing this document, I acknowledge and agree to the following regarding 716 Promoting Animal Welfare & Safety's foster-to-adopt program:

1. The animal is and shall remain the sole property of the 716 PAWS until the adoption is finalized and paid for. If for any reason the adoption is not finalized, I understand that upon the request of 716 PAWS the animal shall be relinquished to 716 PAWS.
2. I understand that I have a predetermined and agreed upon number of days from taking possession of the dog to decide if I am going to adopt the dog. By end of day on {endDate} if a decision is made to adopt, the full adoption fee is required immediately. If I opt not to adopt the dog, I must foster the dog until a suitable foster or adoptive home can be found for the dog. This process could take up to two weeks and I agree to foster the dog during this time.
3. While you are "fostering" a dog with 716 PAWS you may not bring any additional dogs into the home without the consent of 716 PAWS.
4. 716 PAWS will supply foster with 1 weeks' worth of food if they choose to utilize it. Adopter must bring a collar and leash to pick up. We suggest the foster family purchase a crate for while the dog is in your care. After the 7 days if the family decides NOT to keep the dog, 716 PAWS will provide food for the remainder of the time the dog is in their care.
5. I will provide the animal with good care, including but not limited to, proper food, fresh water, shelter, exercise, grooming, training and medication when required.
6. I will comply with all instructions received from the 716 PAWS and will not deviate from any instructions as to the care and maintenance of the animal without consulting with a representative of the 716 PAWS.
7. I agree to maintain the animal as my own household pet and companion.
8. I agree not to abandon, trade, give away, or sell the animal, nor is the animal to be used or sold for commercial use or research purposes. If I no longer desire or am unable to keep the animal within the terms of this agreement, the animal must be returned to 716 PAWS. The animal is NEVER to be turned over to an animal shelter or passed to another owner.
9. I agree to keep the animal under my control and not let the animal roam freely outside of the home.
10. I will provide a safe and loving home environment and will socialize the animal to humans and other animals.
11. I agree to properly supervise said animal at all times.
12. 716 PAWS is responsible for the dog's vetting costs until I have adopted the dog. I am required to take the dog to all scheduled medical appointments. I understand that if I neglect to bring the dog/pup to their appointment that I forfeit all rights to the dog/pup and they will be confiscated by a 716 PAWS member. If that occurs, I understand that any and all vet fees or adoption fees paid by me are non-refundable.
13. I understand that other animals in my household could be exposed to medical or behavioral conditions that have not been recognized in the foster animal placed with me by 716 PAWS, and that 716 PAWS is not liable for any disease or injury of my own companion animals or other exposed animal.

14. I agree not to attempt to hold the 716 PAWS responsible for any damages which the animal may do to any person or property. I specifically release 716 PAWS of any responsibility pertaining to any damage to property or personal injury or any occurrence relating to the animal and shall hold 716 PAWS harmless regarding any damage or injury(ies) of any nature whatsoever, and agree to notify 716 PAWS immediately of any damages and/or injury(ies).
15. I recognize this is an Agreement and have signed this Agreement freely and voluntarily.
16. I agree that I will abide by the same rules as I agreed to on the original application as it pertains to the pup/dog until such time as the adoption is completed.

In order to be accepted into this program, Foster-to-Adopt applicants must sign the Foster to Adopt Agreement which requires compliance with all of the Foster-to-Adopt terms and conditions, including the adoption procedures.

By signing, I understand and agree to all of the above terms.
